
Fellow Cardinals, working together is the key foundation for building a vibrant institution such as the William V.S. Tubman High School.

#### WHAT WE HAVE DONE from 2016 thru 2023

We were able to accomplished the following as an Association for our Alma Mater:

- We were able reaffirmed our commitment in ensuring and re-building *Trust, Accountability* and Respect amongst Association Members
- We were to re-established decades-long Bilateral Educational relationship between San Francisco State University and William V.S. Tubman High School established in 1968 based on the mutual goals of providing quality educational opportunities to the students of William V.S. Tubman High School in Monrovia, Liberia.
- <u>In 2016</u>, we completed a project worth USD \$6,000.00 on the campus of the William V.S. Tubman High School in Monrovia, Liberia. We constructed a new "<u>Water Well</u>" which was supported by a 2HP Submersible Electric Pump that will assist with the supply of water to six (6) already installed reservoirs with a capacity of 2000 gallons of water each thus improving the supply of safe drinking water to the school; and also restored the "Existing Water Well" which was damaged. The project started Mid-June 2016 and Ended Mid-July 2016.
- \* We received **5 New Laptop computers** on behalf of the William V.S. Tubman High School donated in fulfillment of their 2015 National Convention pledged by Cardinals Mr. Amos Gore Kamara and Mrs. Portia Gray-Kamara of the Multicultural Community Family Services, Upper Darby, PA. and presented to the school Administration by Cardinal Amos C. Tarley Sr
- \* <u>In 2018</u>, we completed the renovation and naming of the School Library to <u>A. Nanu Manley Memorial Library</u> worth more than USD \$11,000.00 and with the courtesy of **Senator Saah Joseph of Montserrado County** we received 15 brand new desktop computers to be used in the Library.
- \* In 2018, we renovated and furnished of Principal's office
- \* In 2018, we were able to complete the renovation of the Sciences (Biology, Chemistry & Physics) laboratories from the proceed generated from the school 50th Golden Jubilee Celebrated which was held simultaneously in the USA and Monrovia, Liberia sponsored by the Association.
- \* In 2023 We delivered a Mini Printer; 60 Boxes of Stationery supplies; and Public Address (PA) system.

We, the graduates and former students of William V.S. Tubman High School residing in the Americas, established 1994 in Trenton, New Jersey envision organizing an Alumni Association to assist our beloved Alma Mater in three categories:



#### **Dr. Glenn Washington Wiahplah Moore**

hails from Sasstown, Grand Kru County, Liberia. He is a graduate of the William V.S. Tubman High School (class of 1980 Valedictorian). He holds a BSc. Degree in Mathematics and Physics from the University of Liberia. Upon graduation, he had the opportunity to attend the United Nations Institute for Population Studies at the University of Ghana in Legon where he earned 2 Master degrees: Master of Arts and Master of Philosophy degrees in Population Studies.

Dr. Moore, served as Professor of demography and statistics at the University of Liberia. In furtherance of his education, he attended the University of Pennsylvania (MA in demography), Temple University (MA in psychoeducational processes, M.Ed. Mathematics Education, and Ph.D. Mathematics), Wilmington University (MSc. Clinical Mental Health Counseling), and Grand Canyon University (Ph.D. Psychology). Dr. Moore served as Adjunct Professor at the University of Pennsylvania, Temple University, Cheyney University, Lincoln University, Capella University, and Welden University.

Our speaker is a licensed psychotherapist in the States of Pennsylvania, New Jersey, and Delaware and is the CEO of Moore and Moore Behavior Health Services, LLC.

Our speaker hails from Sasstown, Grand Kru County . He grew up in Greenville, Sinoe County and attended the United Methodist Elementary and Junior High School under the principalship of Samuel A. Ross, III. He showed early promise, graduating as the head of class for both the elementary and junior high school divisions. Our guest speaker later attended the William V. S. Tubman High School where he also graduated as valedictorian of the class of 1980. Three years later, he obtained his BSC in mathematics and physics from the University of

Between 1985 and 1987, he read population studies at the University of Ghana to obtain the Master of Arts and Master of Philosophy degrees under the aegis of the United Nations Funds for Population Studies. He later served as professor of demography at the University of Liberia.

A year later, he earned his Master Degree in Demography from the University of Pennsylvania. Typical of the Kru people who have a strong affinity for academia, he eventually obtained from Temple University a Masters in Psychoeducational Processes, and a Masters and PH.D. in mathematics. A few years later, he obtained a Masters in Clinical Mental Health Counseling from Wilmington University and a second doctorate in Psychology from Grand Canyon University.

Dr. Moore served as Professor at Temple University and Cheyney University respectively. While at Temple University and Temple University Hospital, he rose through the ranks as Student Advisor for baccalaureate to doctoral students, adjunct professorship and Multi-Section Hospital Administrator for Infectious Diseases, Hematology, and Oncology. For more 2 decades plus, he served as an instructional leader and educational consultant to The School District of Philadelphia. He is a licensed psychologist in the states of Pennsylvania, New Jersey, and Delaware and is President and CEO of We Care Family Services, Inc. and Executive Director of Moore and Moore Tax and Financial Services. He is a single father of a set of twin boys and two daughters.
